RELEASE OF LIABILITY

ACKNOWLEDGMENT OF RISKS, AND ACCEPTANCE OF RESPONSIBILITY, BY ADULT CANOE TRIP PARTICIPANTS (18 YEARS OF AGE AND OLDER)

VOLUNTARY PARTICIPATION: I understand that I am about to voluntarily engage in the activity of canoeing and camping in the wilderness areas of northern Minnesota and/or Ontario, Canada, and/or Manitoba, Canada, utilizing equipment and/or services of JOHN C. SCHIEFELBEIN and MARY K. SCHIEFELBEIN (d.b.a. NORTH COUNTRY CANOE OUTFITTERS), their partners, agents, and employees, hereafter jointly referred to as NCCO.

ACKNOWLEDGMENT OF RISKS: I understand these activities bear certain known risks, as well as unanticipated and unknown risks which could result in damage to property, injury or death, to myself or to other persons in my group.

Ibelieve NCCO has specifically explained to me the danger and potential for danger the following known risks: (commonly stems from not correctly wearing personal flotation devices) \boxtimes moving water situations (i.e.: any and all rapids, waterfalls, river currents, etc.)

X lightning (on water or on land) \boxtimes wind (on water or on land) X domestic fire (i.e.: stoves, campfires, etc.) X wildfire (i.e.: forest fire, brush fire, etc.)

X (i.e.: rocks, trees, tree branches & limbs, etc.) falling objects

X trip hazards (i.e.: rocks, stumps, roots, uneven ground, etc., in camp, on portages, hiking, etc.) X wildlife & plants (i.e.: kicking, scratching or biting animals, poisonous plants & berries, etc.) X

(i.e.: lack of quick response medical help and/or difficulty with emergency evacuation, etc.) absence of medical assistance

I understand that there are also unknown risks which cannot be anticipated, and that I cannot be informed about all of the potential risks and dangers inherent to wilderness canoeing and camping. The wilderness area I am about to enter is a constantly changing environment.

Ibelieve NCCO has adequately warned me of the risks to which I and the members of my group will be exposed. I accept these risks as part of this activity. I have advised the members of my group of each of the known and projected risks, and agree that each member does recognize the risks of property damage, personal

injury or death while participating in the wilderness canoeing and camping activity.

I specifically acknowledge that I have been warned by NCCO to:

wear personal flotation devices at all times while on or in the water

avoid traversing (shooting) all rapids, waterfalls, fast moving water situations.

NEGLIGENCE: I understand that property damage, personal injury or death may result from risks incident to my wilderness canoeing and camping activity. In such event, I or my heirs may have the right to make a personal negligence claim against NCCO.

It is specifically NOT my indent to release NCCO from liability for GROSS NEGLIGENCE or for INTENTIONAL TORTS.

RELEASE FROM NEGLIGENCE: In partial consideration of NCCO providing me with outfitting and other requested services from me and members of my group, I release JOHN C. SCHIEFELBEIN, MARY K. SCHIEFLBEIN, NORTH COUNTRY CANOE OUTFITTERS, their partners, agents, and employees, from any and all liability, claims, demands, actions or rights of actions, for property damage, personal injury and death, which are related to or are in any way connected with my voluntary participation in canoeing and camping in the wilderness areas of northern Minnesota, and/or Ontario, Canada, and/or Manitoba, Canada for their collective acts of ordinary negligence or ordinary negligent omissions, or for negligent acts of me or other members of my group. I understand that I am releasing NCCO in advance for any negligent act or negligent failure to act that cause property damage, personal injury or death, for which I would otherwise have the ability to make claim. I also release NCCO for any acts of my own negligence, as well as any negligent acts of members of my group.

TRIP PREPARATION: I understand the owners, employees, partners, and agents of NCCO are not able to make any judgement as to my physical fitness, mental ability, canoeing experience, and camping experience, as each relates to participating in this wilderness canoeing and camping activity. I have represented to NCCO that I am physically and mentally prepared to participate in this wilderness activity, and I am competent to evaluate wilderness canoeing and camping situations as they arise. I have further represented to NCCO that I, along with the other members of my group, have evaluated our own skills and experience levels, and we each believe that every member is adequately skilled and prepared for this wilderness activity.

USE OF EQUIPMENT: I understand the purpose and intended use of all equipment that I furnish, or that is furnished by or purchased from NCCO, and agree to use this equipment only for the manufacturer's intended purpose and use. I accept full responsibility and full liability for personal injury or death to myself or others, arising from the misuse or non-conforming use of all such equipment.

APPLICABLE LAW: I understand this contract is intended to be construed under the law of the state of Minnesota. If any portion of this contract is later found to be invalid or unenforceable, then the balance of this contract shall, notwithstanding, continue in full force and effect.

I fully recognize that if any property is damaged, or if anyone is hurt or killed while I am engaged in this wilderness canoeing and camping activity, that I will have no right to make a claim or to file a lawsuit for injury or death against John C. Schiefelbein, and/or Mary K. Schiefelbein (d.b.a. North Country Canoe Outfitters), their partners, agents, and employees, regardless of any determination of fault. This contract is effective the date when signed, and continues for the duration of this activity until I depart NCCO's property to commence my travel to return home.
